# Legislative Update

This past winter marked the beginning second year of the 103rd General Assembly. This Assembly was originally seated in January 2023, and will run until a new one is seated in 2025.

Historically, the second year of a General Assembly typically has fewer bills introduced than the first year, and this one is no exception:

Year Introduced	2023	2024	Total
House Bills	4,315	1,474	5,789
Senate Bills	2,644	1,275	3,919
Total	6,959	2,749	9,708

The deadline for introduction of new bills in each chamber was February 9. After that, committee work began, with committees in each chamber reviewing bills until the committee deadline, which was March 15 in the Senate and April 5 in the House. After committee action floor debates take place. The Senate has set a deadline of April 12 to act on bills originating in the Senate; the House has set a deadline of April 19 for its bills.

Any bill passing in the initial chamber must repeat the process in the opposite chamber during April and May. Both chambers have set May 3 as a deadline to have bills out of committee, and May 17 is the deadline for final action. Adjournment is scheduled for May 24.

Once a bill has passed both chambers, it must be transmitted to the Governor within 30 days; the Governor then has 60 days to act on those bills.

The IACO Legislative Committee continues to monitor the work of the General Assembly. The legislative chair of each affiliate organization monitors legislation that will impact the duties and responsibilities of its membership. When legislation is proposed that impacts more than one affiliate, the IACO Legislative Committee works to promote cooperation among the affiliates for a positive result for all involved.

**At the Spring conference, be sure to join us for our legislative breakfast on the morning of Thursday, May 16. Our guest will be Jessica Basham, a Springfield veteran with more than two decades experience as a senior legislative aide, and was the first woman to be the Chief of Staff to an Illinois House Speaker. Jessica will talk about the inner workings of the Illinois legislature, and will answer questions from the audience as time permits.**

**REMINDER: [Public Act 103-318](#)**

Effective July 1, 2023 provides that a separate additional Special Revenue Fund be set-up to record receipt of the annual State of Illinois Stipend payments for the officers eligible in each county in the offices of County Assessor, Auditor, Coroner, Sheriff, & Treasurer. The state will now be sending payments directly to the County. This does NOT affect the Circuit Clerk, County Clerk, or Recorder. They will receive a check directly made out to each as in the past years. The County payroll clerk will need to be notified of receipt to issue a check to the correct recipient through the County payroll system within 10 business days after. These payroll checks will include all applicable payroll taxes and pension payments as any other received by the same official.

# 2023 County Official of the Year (COTY)

## Kathy Keefe - McHenry County Circuit Court Clerk

During the 2023 IACO Fall Conference, we had the distinct honor of recognizing Katherine "Kathy" Keefe, McHenry County Circuit Clerk, as our 2023 County Official of the Year. The nomination that her friends, family, and close colleagues put together shined a light on her as an outstanding public servant. Kathy has provided 36 years of servant leadership within the walls of McHenry County Government and has served in a variety of capacities. For the last 15 years, she has served as the elected Circuit Clerk. She leads an office of over 50 employees who serve the 6<sup>th</sup> most populated County in the State of Illinois. The depth of her knowledge, experience, service, and leadership has been recognized county-wide. Kathy has leveraged technology in numerous ways to promote communication, collaboration, and change. Change that has resulted in millions of dollars in current and future savings for McHenry County citizens. She leads one of the most technologically advanced and efficient public offices in the State of IL and was one of the first to move her county to electronic filing.

Kathy was appointed by the Illinois Supreme Court as a member of the Illinois Supreme Court Judicial Conference, developing a strategic agenda for the Illinois Judicial Branch. She was appointed by the Illinois Association of Court Clerks on the Statutory Court Fee Task Force, serving as chairperson of the Criminal/Traffic Subcommittee, which is charged with making recommendations to the Illinois State General Assembly to address barriers to access to justice and additional issues associated with fees and other court costs in Civil, Criminal and Traffic Proceedings. She was also appointed by the Illinois Supreme Court to the Illinois Judicial College as a member of the Committee on Education. She has improved court processes by affording her vast court experience to the IL Judicial College which trains Circuit Clerks who then take that knowledge back to their local courts to implement legislative changes as taught by the Judicial College. Her service to her affiliate runs deep. After all of this, she still steps up to the plate and serves as her affiliate as zone chair. Her contributions have been recognized by officials at the local, County, and State level. Kathy has a servant's heart that goes beyond the office. She volunteers, supports numerous community organizations, and was awarded the Turning Point Peace and Justice Award in 2011. Her nominators contributed the following to further describe her dedication to public service.

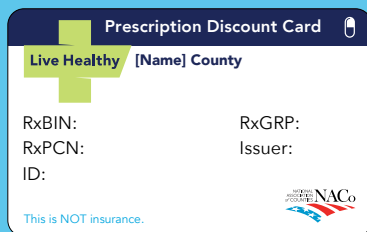

## WHY MENTAL HEALTH FIRST AID?

Mental Health First Aid (MHFA), a skills-based training administered by the National Council for Mental Wellbeing, teaches people how to identify, understand and respond to signs and symptoms of mental health and substance use challenges in their peers, friends and colleagues.

To help the National Association of Counties (NACo) realize its vision of creating healthy, safe and vibrant counties across America, the National Council and NACo are partnering to offer crucial MHFA trainings to county employees and the communities they serve. The National Council-NACo partnership will support elected officials and county staff, who are asking for help with their own mental health and wellbeing. And, by extension, create a framework for counties to destigmatize mental health and substance use issues as they provide community residents with more equitable access to quality mental health and substance use treatment services.

## WHAT MHFA COVERS

- Noticing signs and symptoms of substance use and mental health challenges.
- Navigating difficult conversations about mental health.
- Knowing that recovery is possible – and how to support it.
- Tackling mental health stigma in the workplace.
- Understanding principles of safety and privacy. Building resilience and strategies to alleviate burnout.
- Implementing a 5-step MHFA Action Plan (ALGEE).
- Reinforcing relevant employee resource groups, employee benefits and HR initiatives.

## WHO SHOULD TAKE IT

- County employees at all levels, including elected officials and county staff across all departments and organizations.
- Human resources and benefits partners, senior leaders and front-line managers.
- First responders including law enforcement, corrections officers, fire and EMS services.
- Hospital and nursing home staff.
- School teachers, administrators and youth-serving staff.
